Student Loan Application Period Open

Attention students! Loan applications are being accepted through July 31st. Requirements are:

- 1. Attended Elwood High School for four years.
- 2. The student is required to be registered as a full-time student (12 hours or more).
- 3. Must maintain a 2.0 grade point average (C) to renew the loan.
- 4. A 2% interest charge will be made while attending college and is payable each semester.
- All loans become due and payable upon completion or discontinuation of college.
- 6. Loans are to be paid back on a five year monthly payment plan at 7% interest.

Applications are available at the Foundation Office. Upon approval by the Board of Directors and signature of a school note by the student and co-signers, the loan is allocated each semester. Payment of interest and a copy of the student's grades verifying 2.0 grade point average is also required. Contact the Foundation Office for additional details.
