Student Loan Application Period Open

Attention students! Loan applications are being accepted through July 25th. Requirements are:

- 1. Be a graduate of Elwood High School.
- 2. The student is required to be registered as a full-time student (12 hours or more).
- 3. Must maintain a 2.0 grade point average (C) to renew the loan.
- 4. A 2% interest charge will be made while attending college and is payable each semester.
- 5. All loans become due and payable upon completion or discontinuation of college.
- Loans are to be paid back on a five year monthly payment plan at 7% interest.

Applications are available at the Foundation Office through July 25. Upon approval by the Board of Directors and signature of a school note by the student and co-signers, the loan is allocated each semester. Payment of interest and a copy of the student's grades verifying 2.0 grade point average is also required. Contact the Foundation Office for additional details.



YELP (YOUTH ENGAGED IN LEADING PEOPLE) LEADERSHIP ACADEMY

The YELP (Youth Engaged in Leading People) leadership academy is a 12-month course offered to sophomore students from Elwood, and Phelps County. The class is taught through a collaboration between the Nebraska Extension, Elwood Area Foundation, and Phelps County Development Corporation.

Each month the group meets in a different location to learn about leadership skills, meet community leaders, and develop a servicelearning project that will provide a benefit to their community. The 2019 participants from Elwood are Kaydee Diefenbaugh, Matteya Gutierrez, and Alivia Knoerzer.

The first YELP group in Elwood met from February through December 2018. The students embraced the concept of the course and all came up with great ideas for a service project that would benefit the community.
